This product is N-Channel MOS Field Effect Transistor designed for DC/DC converters and power management switch.

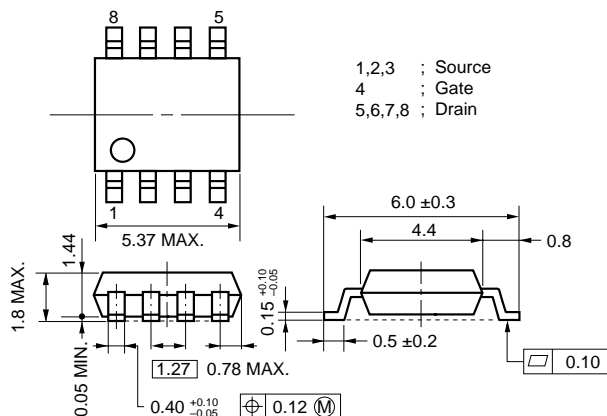

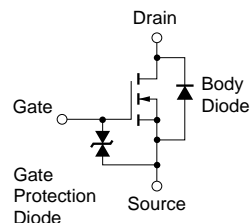

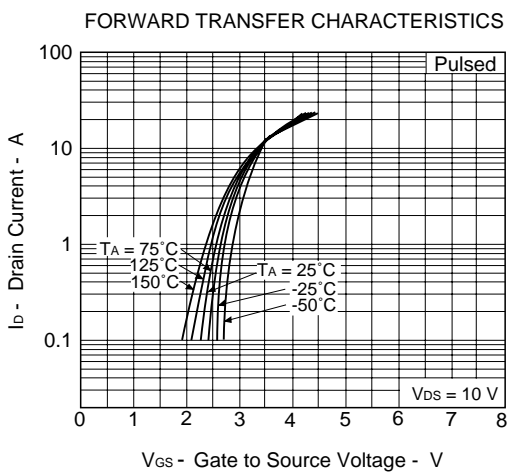
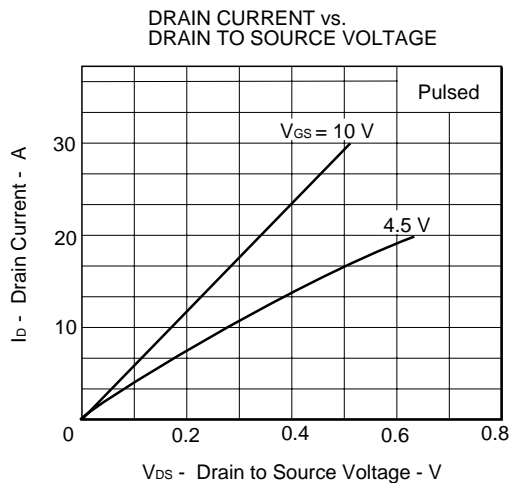
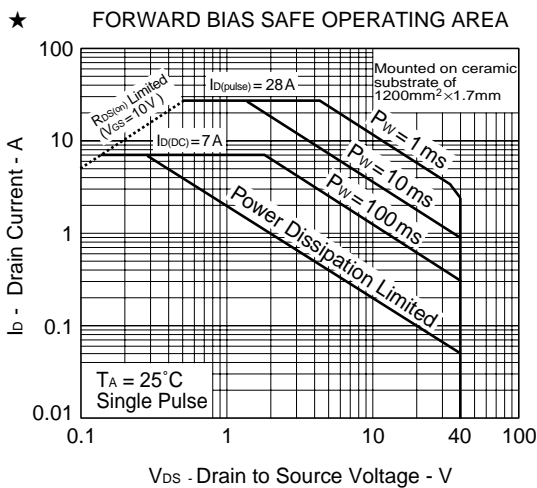
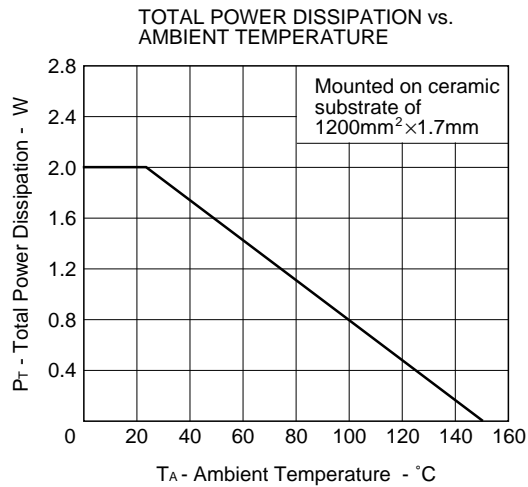
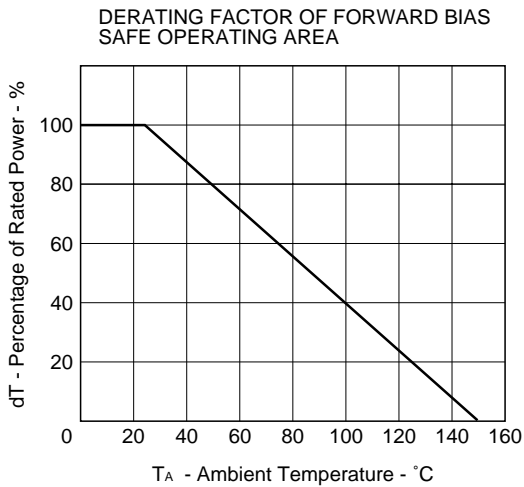
TEST CIRCUIT 1 SWITCHING TIME



TEST CIRCUIT 2 GATE CHARGE

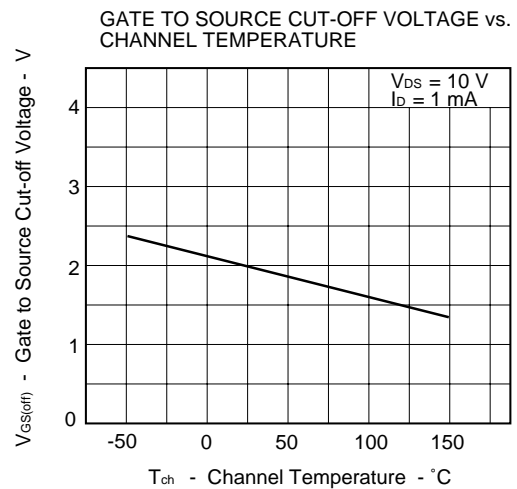
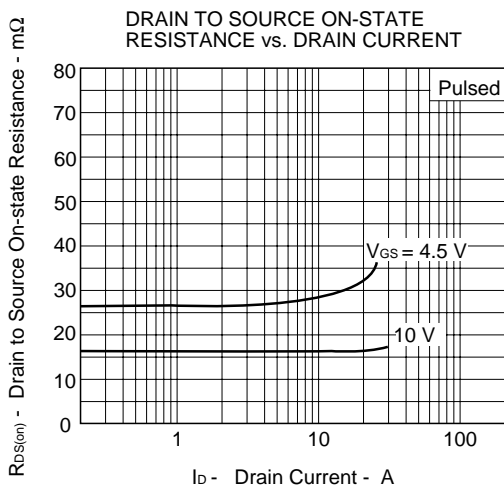
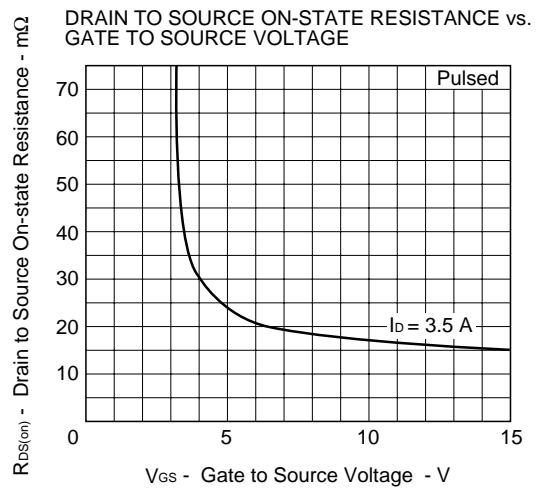
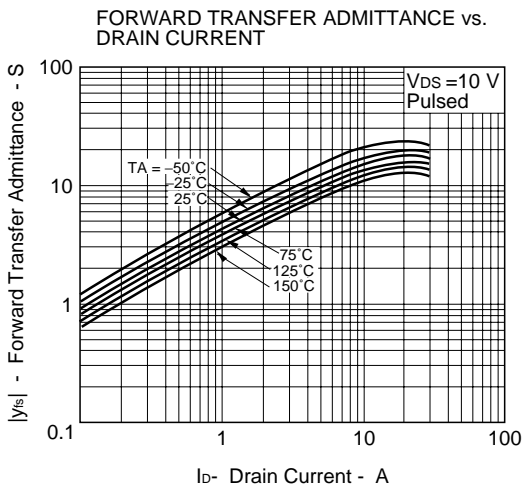
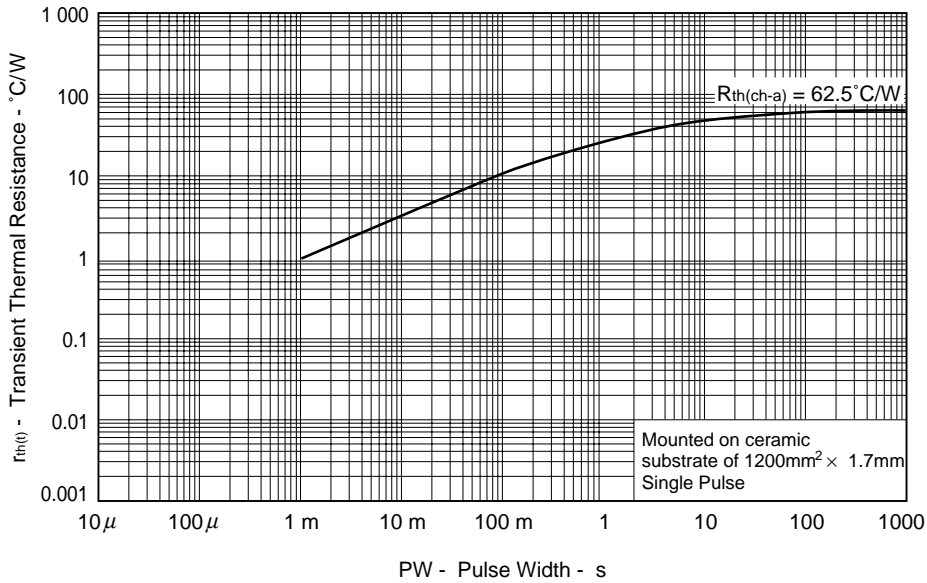


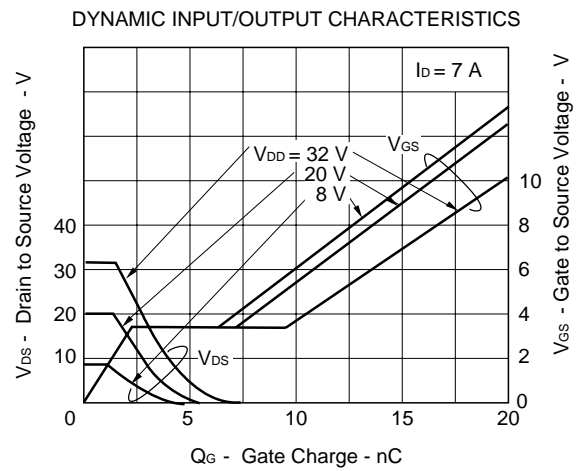
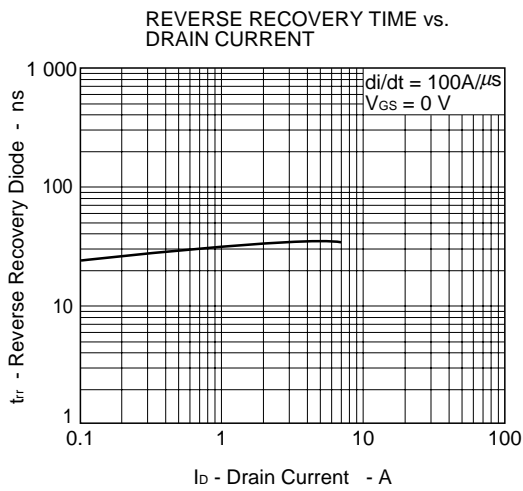
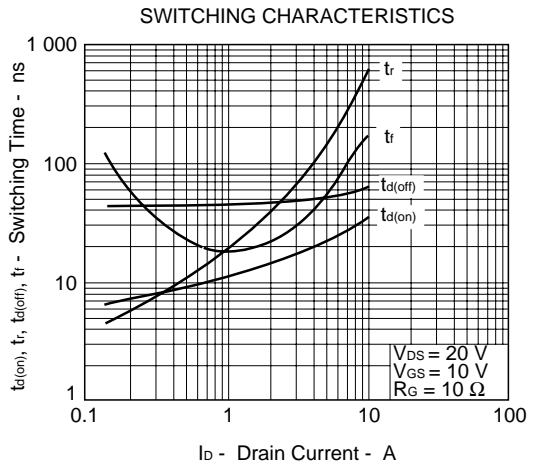
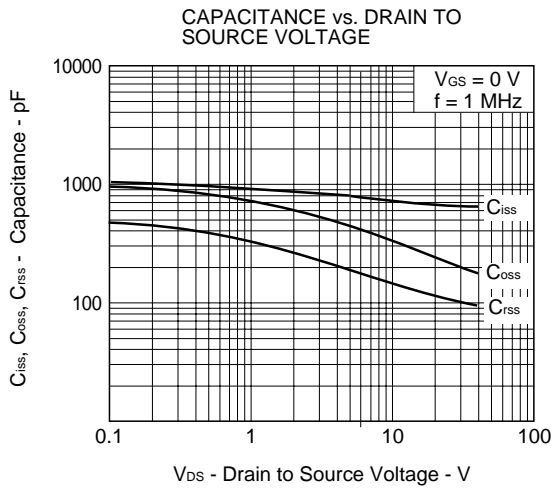
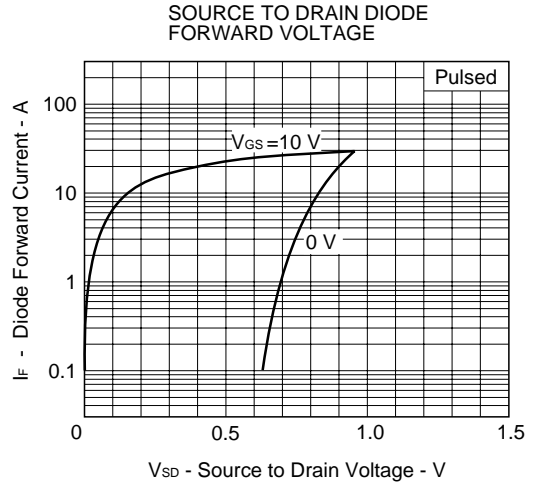
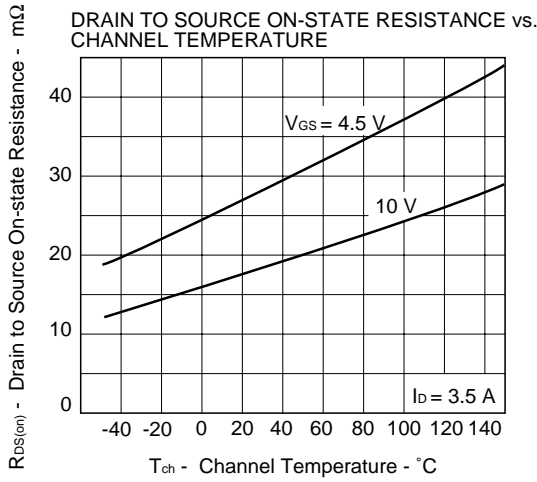
TYPICAL CHARACTERISTICS ($T_A = 25^\circ\text{C}$)
